- My parent(s)/guardian(s) are legally responsible for my actions.
- I will not let anyone else drive any vehicle entrusted to me.
- I will not consume drugs or alcohol and I will not operate any vehicle while under the influence of drugs or alcohol, or while I am impaired in any way.
- I will not be a passenger in any vehicle that is under the control of someone who has used drugs or alcohol, or someone who is impaired in any way.
- Everyone in the vehicle will wear a seat belt and keep it fastened at all times.
- I will not text and drive. I will also make sure to keep my full attention on safely and lawfully driving.
- I will drive in a safe and lawful manner.
- I will make sure that my parent(s)/guardian(s) are aware of my destination and time of return prior to using the vehicle. I will notify them if I am running more than ____ minutes late.
- I will call my parent(s)/guardian(s) at any time, day or night, for advice and/or transportation for any reason whatsoever because I know that my parent(s)/guardian(s) are concerned about my safety and welfare first and foremost.

Parent(s)/Guardian(s) Understand and Agree That:

- I will listen to explanations or concerns expressed by my youthful driver regarding the operation of a vehicle or the terms of this contract.
- I will serve as a good role model and abide by similar safe driving terms especially in regards to the use of seat belts, no texting, no drugs or alcohol consumption, safe and lawful driving habits, and the like.
- I will ensure the mechanical safety of any vehicle used by my youthful driver.
